

# ARTICLES OF AMENDMENT NONPROFIT CORPORATION

### ARTICLES OF INCORPORATION OF CABARRUS COUNTY TOURISM AUTHORITY

The undersigned, being of the age of twenty-one years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a nonprofit corporation under and by virtue of the State of North Carolina.

#### ARTICLE 1

The name of the corporation is CABARRUS COUNTY TOURISM AUTHORITY.

#### ARTICLE 2

The period of duration of the corporation shall be perpetual.

#### ARTICLE 3

The purpose for which the corporation is organized is to promote tourism, tourist-related support services and facilities, tourist-related events, tourist-related activities, or tourist attractions in and for Cabarrus County, North Carolina. In furtherance thereof the corporation may receive property by gift, devise or bequest, invest or reinvest the same and apply the income and principal thereof as the Board of Directors may from time to time determine in support of the corporation's purposes. The corporation shall have all the general powers enumerated in Chapter 55A of the North Carolina General Statutes as now in effect or as may hereafter be amended.

#### ARTICLE 4

The corporation shall have no members.

#### **ARTICLE 5**

The initial registered office and principal office address of the corporation shall be 3003 Dale Earnhardt Boulevard, Kannapolis, Cabarrus County, NC 28083. The registered agent of the corporation at that address shall be John Mills.

#### **ARTICLE 7**

The name and address of the incorporator is:

#### **ARTICLE 8**

No part of the net earnings of the corporation shall inure to the benefit of the directors or officers of the corporation or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3.

#### **ARTICLE 9**

Upon dissolution of the corporation, its assets shall, after all of its liabilities and obligations have been discharged or adequate provision made therefor, be distributed to Cabarrus County or to any association or associations organized for purposes similar to those set forth in Article 3 hereinabove, all as more particularly provided in the bylaws of the corporation.

#### **ARTICLE 10**

The board of directors may provide in the bylaws of the corporation that the corporation shall indemnify its current and former directors, officers, employees and agents against expenses and liabilities incurred as a result of actual or threatened litigation arising from the performance of their official duties. The indemnification provided by this Article shall not be deemed exclusive of any other rights to which such directors, officers, employees or agents may be entitled under any bylaw, agreement, resolution of the Board of Directors, or otherwise.

#### **ARTICLE 11**

The private property of the officers and directors of the corporation shall not be subject to payment of corporate debts to any extent whatever.

#### **ARTICLE 12**

These Articles of Amendment shall be effective upon filing.
